Let's Talk About Text, Baby!

This presentation will outline the good, the bad, and the ugly results of two clinics' leap into the world of mobile technology. Attendees will hear first-hand the initial results of a pilot project aimed at implementing the Care Message texting platform to improve Diabetes Care visit attendance and engagement. Instead of re-inventing the wheel, come learn what worked, what didn't work, and what we would do differently next time.

Winner: Norwegian American Hospital Care-A-Van

Low-income children in Norwegian American Hospital's primary service area experience many barriers to accessing basic health services, resulting in children being behind on screenings and vaccines. Physicals and vaccinations are mandatory for entering certain grades in school; without these, children are at risk of missing school. In 2009, Norwegian began Care-A-Van.

Care-A-Van is a state-of-the-art mobile clinic providing preventive care to underserved children in coordination with Chicago Public Schools. The services – including physicals; immunizations; and lead, hemoglobin, hearing and vision screenings – are completely free and delivered at schools. Care-A-Van saw an average of 1482 patients and provided 4309 services annually. While this was consistent with other mobile programs and school based health centers, Norwegian knew the need was even greater.

A transformation in the staff model allowed the program to grow dramatically. In 2014, instead of a separate, non-clinical manager, Care-A-Van recruited and hired a Nurse Practitioner to manage the program. The NP integrated scheduling, clinical care, management and patient follow-up to allow greater volumes of patients. She implemented innovative program design enhancements, including: redefinition of service area, new consents and parent communications, improved coordination with schools, and consistent use of Illinois' statewide immunization database. Care-A-Van also became a CLIA laboratory.

Now Care-A-Van serves over 3000 children annually across 80 schools. Patient count increased 114% and services provided increased 206%. Care-A-Van also translated all forms into Spanish. In addition, the NP increased coordination with other hospital departments including pharmacy, risk management, infection control and security. Over 3100 referrals to other hospital services were made in FY16.

Mental & Behavioral Health: Assessment & Interventions for Patients with Depressive Symptoms

This workshop will provide an overview of targeted interventions that have proven beneficial to the improvement of physical and mental wellbeing in patients with self-reported depressive symptoms. Presenters will include findings from an assessment of self-reported depressive symptoms among 863 patients; this assessment breaks down differences across gender and languages, as well as for those diagnosed with diabetes. Also reviewed will be lessons learned from years of group programming targeting whole-self care, with emphasis on complementing established physical and mental health care.

Following the workshop, participants will be able to:

- 1. Understand the differences for varying severity of self-reported depressive symptoms across language and gender
- 2. Understand the importance and implications of creating "community-within-group" specific to health management
- 3. Identify the best use of limited resources for targeted clinical interventions

What does it mean to be a "welcoming" clinic? And how can the free and charitable clinic sector best serve populations that remain ineligible for health insurance post-ACA? As Health Policy Director at the ICIRR, Luvia spearheaded a coalition effort to win healthcare access for undocumented residents in Cook County; she will provide a statewide context as well as insights from the perspective of potential new patients. Angie transformed Community Health Care Clinic into a bilingual and trauma-informed practice when she became executive director; she will share lessons learned and strategies to gain community trust.

- 2. Understand the concerns and risks undocumented immigrant adults face when seeking necessary services

The Train Has Let the Station – Are You Onboard?

IAFCC Quality Improvement Work Group

Why? Why bother with all this data stuff -- isn't it enough that we provide healthcare? With ACA's Triple Aim and the concepts of population management and fee for value, virtually all sectors in healthcare are compiling and reporting data. Mobile clinics even calculate the value of services provided by plugging in data!

Who? Other state associations have started down this road as well, and for good reason. Wisconsin is creating its own "Standards of Excellence." Ohio, Pennsylvania, Virginia and North Carolina require member clinics to report data – but there is no national coordination. Illinois (that's us!) has a Quality Improvement Work Group that wants YOUR input and ideas.

How? We are starting with two patient outcomes data points. Come learn how to collect and report.

When? Twice a year. Your data points will impress your funders, too.

PRESENTER PROFILES

George L. Bakris, MD, Hon DSc, FASH, FASN, FAHA

Dr. Bakris received his medical degree from the Rosalind Franklin School of Medicine and completed residency in Internal Medicine at the Mayo Graduate School of Medicine where he also completed a research fellowship in Physiology and Biophysics. He then completed fellowships in Nephrology and Clinical Pharmacology at the University of Chicago. From 1988 to 1991, he served as Director of Renal Research at the Ochsner Clinic and had faculty appointments in the Departments of Medicine and Physiology at Tulane University School of Medicine. He later was Professor and Vice Chairman of Preventive Medicine and Director of the Rush University Hypertension Center in Chicago from 1993 until 2006. Currently, he is a Professor of Medicine and Director of the ASH Comprehensive Hypertension Center in the Department of Medicine at the University of Chicago Medicine.

Dr. Bakris has published over 700 peer-reviewed articles and book chapters in the areas of diabetic kidney disease, hypertension and progression of nephropathy. He is the Editor or Co-Editor of 20 books, in the areas of Kidney Disease Progression and Diabetes as well as the new edition of Hypertension: A Companion to Braunwald's The Heart. Additionally, he is an Associate Editor of the International Textbook of Cardiology. He was a member of the NIH National High Blood Pressure Education Program Working Group on Hypertension and Renal Disease (1994). He also serves as a special government expert to the Cardio-renal Advisory Board of the FDA and to CMS. He was a co-principal investigator on the NIH Clinical Research training grant for clinical research (K30) (1999-2004). He chaired the first National Kidney Foundation Consensus report on blood pressure and impact on renal disease progression (2000). He has also served on many national guideline committees including: The Joint National Committee Writing Groups VI & 7 (1997, 2003), the JNC 7 executive committee (2003), the American Diabetes Association Clinical Practice Guideline Committee (2002-2004), the National Kidney Foundation (K-DOQI) Blood Pressure Guideline committee (2002-2004 & 2013) and (K-DOQI) Diabetes Guideline committee (2003-2005 & 2014). Dr. Bakris is the past-president of the American College of Clinical Pharmacology (2000-2002) and the American Society of Hypertension (ASH). He is the current Editor-in-Chief, Am J Nephrology, Editor-in-Chief- Up-to-Date, Nephrology section, Hypertension Section Editor Up-to-Date and Assoc. Ed of Diabetes Care. He serves on more than 18 editorial boards including Nephrology, Dialysis & Transplant, Hypertension and J American Soc. Hypertension.

Laura Bollan

As the director of Healthy Communities at Sarah Bush Lincoln, Laura Bollan oversees the Healthy Kids Program as well as Dental Services, which serves students in a nine-county area with free dental care to woman and children in need. Laura Bollan has an extensive background in training and professional development. Since 1991, she has developed and delivered workshops in corporate, educational, and community-related settings. Her skills, experiences, and accomplishments have enabled her to align training with companies' visions, thus increasing their revenue and productivity. Laura is certified in the application of the Herrmann Brain Dominance Instrument, and a licensed Life Orientations Trainer. She is also a certified Financial Peace University Workplace Facilitator

Julie Darnell, PhD, MHSA

Dr. Darnell's research focuses on access to, and the delivery and financing of, health care for poor and vulnerable populations and the safety net organizations that serve them. She has earned a national reputation for her work on free clinics, which are volunteer-based nonprofit clinics that provide healthcare services at little or no charge to low-income people who are predominantly uninsured. Findings from her research on free clinics have been published in the Archives of Internal Medicine and Medical Care and in a report to the U.S. Congress. Her work on free clinics has received numerous awards and recognition from organizations including the Society for Social Work and Research, the National Association of Social Workers Foundation, the Association for Research on Nonprofit Organizations and Voluntary Action, the American Public Health Association, and the Public Health System Research Interest Group of AcademyHealth. She received her master's and doctoral degrees in Social Service Administration from The University of Chicago. She also has a master's degree in health services administration from The George Washington University.

Suzanne Hoban, MPH

Suzanne is the Executive Director of the Family Health Partnership Clinic in Crystal Lake. She began her career in refugee resettlement, both stateside as well as in Asia and Central America. Her interest in public health grew after she returned from a refugee camp in Malaysia and discovered that it was easier to get health care on an island in the middle of the South China Sea than if you had no insurance in the middle of Chicago. After receiving her Master's in Public Health, she worked for the McHenry County Department of Health and the McHenry County Mental Health Board where she began the quest to start a clinic for the uninsured in the county. She won initial grant funding and started the Family Health Partnership Clinic in Harvard in 1996. This Clinic was, for years, the only source of care for the uninsured and underinsured of the county. Suzanne is a member of the Illinois Association of Free & Charitable Clinics boards of directors.

Melissa Maguire, MSASS

Melissa is the Vice President of Mission Fulfillment for The Night Ministry. In this position she is responsible for developing tracking and feedback systems that are used to improve services and promote sustainability for the organization. Melissa joined The Night Ministry in 2001 as the volunteer coordinator. In 2002 she oversaw a community program for at-risk teen parents. In 2006, Melissa was the Program Director for a homeless teen parent shelter program that had a research and evaluation component that was acknowledged as a best practice for subsequent teen pregnancy prevention. For the past two years, Melissa has been working with the OHM team to determine indicators the street outreach team can use to identify effective strategies for engaging and supporting individuals in outreach and health services.

Carla Pinto, MD

Carla Pinto is a Foreign Medical Graduate, born and raised in Guinea Bissau, West Africa. From a young age she had the desire to become a doctor and serve the community. She enrolled at China Medical University where she graduated as an MD. Shannon Watson, BA

Shannon is the executive director of Tri City Health Partnership in St. Charles. Shannon brings experiences from a diverse background of medicine, family therapy, gourmet confections, social activities and events director, public speaking, auctions operations and most recently, executive director of the free medical clinic in St. Charles.

Adelle White, BS

Adelle has a BS in Biomedical Sciences with a focus on Nutrition & Exercise Science from Marquette University. Adelle oversees health education programming at both of the CommunityHealth clinic sites and provides free offsite workshops focusing on fitness and nutrition for families residing in Chicago's 'food deserts.' In addition to training and supervising all Health Education volunteers, Adelle evaluates and updates curricula, provides clinical analysis of health center data to assess the success of health education classes, teaches dance aerobics and healthy cooking classes, and is responsible for large-scale onsite events aimed at improving overall health for patients and community members.

Harvey Wigdor, DDS, MS

Dr. Wigdor received his DDS from University of Illinois College of Dentistry in 1976 and MS in Oral Pathology in 1984. He was Chairman from 2001-2015 and now Vice Chair and former Director of the General Practice Residency, Department of Dentistry Advocate Illinois Masonic Medical Center in Chicago.
