A WORD FROM THE BOARD CHAIR



Dear Members and Friends.

If there is one constant in healthcare, that constant is change. Anyone in the healthcare world must adapt to constantly changing times to best overcome the challenges of an ever-changing landscape, demographic diversity, and new policies. Over the years, IAFCC has advocated for Illinois' free and charitable clinics and over the past 2 years alone, secured \$13 million to help clinics do what they do best provide high quality, free or charitable, compassionate healthcare to those that would otherwise go without. And while \$13 million sounds like a lot over the past 2 years, when you consider that clinics in Illinois save the state over \$55 million in averted ER visits and the provision of medical care each year, the state of Illinois has gotten a bargain. This savings is achieved through the dedication, passion, commitment, and hard work of numerous staff, volunteers, and partners of free and charitable clinics across the state. Therefore, we hope the state restores the yearly allotment to \$9 million for the next fiscal year.

As we move towards the future, we must continue to engage in what Eddie Obeng in his Ted Talk describes as Smart Failure. The world is moving at a faster pace than our ability to learn so therefore, we must be willing to pioneer ideas and strategies that are relevant, adaptable, malleable, and even risky. The alternative is spending too much time trying to get everything exactly right only to discover the world has changed during that time and the effort to get it perfect has passed because our plans are no longer relevant. Obeng suggests that you move forward and risk failing because at least something is being done and even if it does not work, you learned something along the way – thus smart failure. This strategy is highly appropriate in the pioneering work IAFCC is doing with DEI and racial justice. As someone who has spoken about and lived in this world of DEI and racial justice for over two decades, I am happy to see IAFCC move forward in creating tangible, measurable, and progressive tactics to truly address health inequities, healthcare disparities, and the alarming statistics and trends indicating how far we are away from a truly equal, fair, and just society. IAFCC is showing that these important issues are not something you address only when extra time and energy is available or when it is trendy. IAFCC is making sure DEI and racial justice is part of the DNA of the association and is apparent in all aspects of the organization. Our desire is to set an example for member clinics to follow in each of their communities, which are full of diversity and need equitable healthcare justice.

In addition to securing funding and infusing DEI and racial justice into the association, Melissa and the wonderful IAFCC staff continue to do amazing work, whether that includes planning and coordinating the yearly conference, communicating to member clinics, securing and managing grants, or countless other tasks. As the IAFCC Board Chair, I am humbled and grateful to be a part of such an impactful organization that is leading the way in supporting the safety- net healthcare system through bolstering the work of free and charitable clinics across the state of Illinois.



IAFCC INITIATIVES

CDC FOUNDATION

IAFCC received funding through the CDC Foundation P4VE Project. P4VE stands for Partnership For Vaccine Equity and focuses on the equitable dissemination of factual information and resources on COVID-19 and flu vaccinations as well as thoughtfully equipping various channels of communications to accurately relay that information. This can happen through a variety of different initiatives such as community partnerships, communications campaigns through social media channels, partnerships with government entities, and more. Three IAFCC clinics were involved with this project and in 2023, reported:

- Partnership with Illinois Department of Public Health through IAFCC
- 6 new Community-based
 Organization partnerships
- more than 70 influential messengers trained,
- 23 events held for community members
- At least 524 new individuals reached at events and received information about and access to vaccinations in conjunction with other health education,
- 27 community member trainings,
- Over 30,000 interactions via social media

MAVEN PROJECT

The MAVEN Project is a non-profit organization that connects a network of expert physician volunteers to safety net clinic providers for medical advice. They empower primary care physicians with an MD, DO, NP, or PA licensure by providing unlimited access to a full suite of services, including peer-to-peer electronic medical consultations, AMA Category 1 continuing medical education, clinical mentoring, and leadership mentoring. Clinics have benefited from utilizing MAVEN's consultations and 1:1 mentoring services. IAFCC members receive the discounted annual partnership fee of \$2,750. The result of their work is rapid access to highquality specialty healthcare, delivered locally to those who need it. Patients avoid unnecessary specialty referrals, and providers gain valuable knowledge applicable to future patients. Overall, their services have a profound impact on our clinics' healthcare delivery, patient outcomes, and total avoided medical costs.

IAFCC INITIATIVES

DEI WORK

In 2023, IAFCC took a big step towards addressing Priority 3: Advancing Racial Justice and Address Social Determinants of Health of our strategic plan. With the guidance of a diversity, equity, and inclusion consultant, IAFCC has put forth effort in completing the first objective: Assess the reediness of the association to advance a racial justice agenda. To accomplish this, IAFCC was tasked with, 1. appointing leadership for the initiative, 2. assessing the commitment of leadership, 3. aligning initiatives to organizational goals, 4. having a thorough review of policies, procedures, bylaws, etc., 5. completing a budget review, and 6. completing a SWOT analysis. To date, IAFCC has accomplished most of these tasks. We have established key leadership for this work by appointing Dr. Jeffery Trask, Board Chair, and Melissa Maguire, Executive Director, as co-chairs of a diversity, equity, and inclusion committee. In addition the committee consists of members of the board, staff, and the community. Other key components that have taken place in this first phase is a complete review of organizational policies, procedures, and bylaws by the consultant. A thorough review led to key recommendations that will be addressed in our next phase. Lastly, IAFCC has a SWOT analysis that sought input from the board members, committee members, member clinics, and community stakeholders. We've identified key strengths and discussed ways to maximize our strengths and opportunities to address our threats and weaknesses. As we look to the next phase, IAFCC is positioned to make changes in the association to move the needle in advancing racial justice in Illinois. - Dr. Markisha Woodson

BEHAVIORAL HEALTH

Funded through the National Association of Free and Charitable Clinics by CVS.

Based on the reported needs of IAFCC members, IAFCC found it necessary to continue and advance our work to best cater to the Behavioral Health needs of Free and Charitable Clinics in Illinois. Working with a group out of Northwestern Medical School's Second Opinions Consulting Group, the goal to gather behavioral health resources and work closely with a workgroup of experts to create a toolkit for IAFCC members was met. The toolkit includes best practices for recruitment, retention, coaching, and training, along with easy-to-use marketing materials for clinics. Then, guided by a focus group of clinic leaders, the toolkit will also include critical protocols for clinics to be able to on-board behavioral health practitioners. To ensure that the final manual is culturally and linguistically appropriate, reaches a diverse group of volunteers, and meets the needs of diverse and unique clinic models, IAFCC hosted an in-person focus group of diverse clinic providers and behavioral health practitioners from across the state to provide experience and feedback to help inform the final version of the 2023 Behavioral Health Toolkit.
